

PRIVACY POLICY

This document details how Flash Engenharia collects and processes users' personal data.

[FLASH INDUSTRIA E COMERCIO DE PRODUTOS E SISTEMAS ELETROELETRONICOS LTDA], registered under CNPJ number [04.844.206/0001-59], with headquarters at [R. Profa. Célia C. Marques Mendes, 1000 - Alto da Boa Vista, Sorocaba - SP, 18087-171], hereinafter simply referred to as Flash Engenharia, is committed to ensuring the privacy and security of its users' and visitors' personal data, in compliance with the Brazilian General Data Protection Law (Lei nº 13.709/2018 - LGPD).

1. PRINCIPLES OF DATA COLLECTION AND PROCESSING

Flash Engenharia processes personal data based on the following LGPD principles:

- Purpose: Processing shall be carried out for legitimate, specific, explicit, and informed purposes to the data subject.
- Adequacy: Compatibility of the processing with the informed purposes.
- Necessity: Limitation of processing to the minimum necessary for the achievement of its purposes.

2. DATA COLLECTED AND PURPOSES

Personal data may be collected when the user:

- Visits the Flash Engenharia website;
- Fills out contact, quotation, or newsletter forms;
- Applies for job vacancies (if there is a "Work With Us" section);
- Interacts with the website via cookies.

3. DATA SHARING

Flash Engenharia does not commercialize users' personal data. Data sharing may occur, strictly when necessary and with applicable legal bases:

- With suppliers and partners (e.g., hosting services, marketing platforms, statistical analysis tools such as Google Analytics), provided that they commit to protecting the data in accordance with the LGPD.
- In case of a judicial request or a legal/regulatory obligation.
- With companies belonging to the same economic group (if applicable), for administrative and management purposes.

4. STORAGE AND SECURITY

Data is stored for the time necessary to fulfill the purposes for which it was collected, or as required by law. Flash Engenharia adopts technical and administrative measures suitable for protecting personal data from unauthorized access and from accidental or unlawful situations of destruction, loss, alteration, communication, or dissemination.

5. DATA SUBJECT RIGHTS

In accordance with Article 18 of the LGPD, the data subject has the right to obtain from Flash Engenharia, at any time and upon request:

1. Confirmation of the existence of data processing.
2. Access to the data.
3. Correction of incomplete, inaccurate, or outdated data.
4. Anonymization, blocking, or elimination of unnecessary, excessive, or non-compliant data.
5. Revocation of consent.
6. Information about data sharing.
7. Elimination of personal data processed based on consent.

6. COOKIES

The Flash Engenharia website uses cookies to improve the browsing experience and analyze traffic. Cookies are small files stored on your device. Upon first access to the website, you will be notified and will have the option to accept or manage your cookie preferences.
